

WHATSAPP GENERAL INFORMATION TEXT REGARDING THE PERSONAL DATA PROCESSING

This Clarification Text refers to Akin Yazılım Bilgisayar İthalat İhracat Sanayi ve Ticaret Ltd. Şti., which acts as the data controller. (Akinsoft), Law No. 6698 on the Protection of Personal Data ("PDPP") 10. with the item regarding the procedures and principles to be followed in carrying out the obligation for the Lighting of the European Union General Data Protection Regulation ("GDPR") and related legislation and resulting from activities within the framework of legal regulations, your personal data are processed for the purposes, legal reasons, assembly method, can be transferred and to whom is intended to inform you about your rights under the PDPP.

WhatsApp Business Account name and surname, phone, e-mail address, personal data of the country and city where you are located, tax registration plate belonging to your company, signature circular, photocopy of identity, etc. that you share through our contact line, your data is processed for the purposes of promoting the products and services offered by our company, carrying out the necessary work to benefit the relevant people from the products and services by the business units, carrying out the relevant business processes.

The personal data in question are subject to Section 5 of the PDPP. item is included in "that is directly related with the formation or performance of a contract, provided the contract parties to be required for the processing of personal data" legal and your contact information in order to send commercial electronic messages to you based on reason, and only on the basis of your consent, legal disputes are processed in an automated manner in the relevant jurisdictions will be shared.

The personal data in question is stored for the period stipulated in the relevant legislation, if a period is stipulated, for the period stipulated; if the period is not stipulated, it is stored for the period during which our legitimate interest continues, taking into account the following criteria.

- Akinsoft Applications
- Applied commercial practices
- The statute of limitations stipulated in the relevant legislation

At the end of these periods, the stored personal data is deleted, destroyed, or anonymized.

As a data subject, within the framework of GDPP and GDPR, you have the rights of ;

- Requesting a copy of your personal data stored by us,
- If you have any personal data that you think is incorrect, request our company to correct it, at the same time, if you have any personal data that you think is incomplete, we will ask our company to request completion,
- Deletion of your personal data from our company within the framework of the conditions stipulated in the Law or demand its destruction,
- In case your personal data is damaged due to unlawful processing requesting compensation for damage,
- You must object that your personal data is accurate or that the processing activity is unlawful however, if you do not wish your personal data to be deleted, your personal request a restriction on the processing of your data,
- Your consent, the effect of which is to cover the future (data processing up to that date provided that their activities remain legitimate) withdraw at any time,
- If you believe that we are processing your personal data in violation of the applicable data protection regulations, you have the right to file a complaint with the competent regulatory authority, primarily your habitual residence or workplace if you live in the European Union or the relevant supervisory regulatory authority in the Member State where you believe a data protection breach has occurred.
